- 32 Sexual assault or aggravated sexual assault against someone other than a school district employee or volunteer
- 33 Possessed, purchase, used, or accepted a cigarett or tobacco product as defined in Health and Safety Code
- 34 School related gang violence (3 or more persons with common identifying sign or symbol)
- 35 False alarm/false report
- 36 Felony controlled substance violation (49) Engages in Deadly conduct
- 37 Felony alcohol violation (50) Non-illegal knife blade equal or less than 5.5 inches
- 41 Fighting/Mutual Combat (51) Firearm off campus but with 300 feet school property
- 42 Truancy- at least 3 unexcused absences (52) Illegal knife, club, dangerous drug or alcholic beverage  
off campus within 300 feet of school property
- 43 Truancy- with 10 unexcused absences (53) Serious offense conduct
- 45 Truancy- failure to enroll in school (54) Felony marihuana,controlled substance,dangerous drug,  
or alcholic Beverage off campus within 300 feet
- 46 Aggravated robbery school property
- 47 Manslaughter
- 48 Criminally negligent homicide
